**KINDERGARTEN REGISTRATION SET
FOR FALL 2018 STUDENTS at WEST END ELEMENTARY**

Registration for those students who will begin kindergarten in the fall of 2018 will be held at the West End Elementary campus in Industry on Thursday, May 3, 2018 from 4:00 p.m. to 6:30 p.m.

Please note the following guidelines:

A. To be eligible for beginning kindergarten the child must be five years old on or before September 1, 2018.

B. Parents must present the following documentation at the time of registration:

1. An official birth certificate obtained from the county offices at the place of birth; not one issued by the hospital.
2. Shot records of all required immunizations. These must be current with all boosters.
 - **DPT:** Five (5) doses of any combination DTaP/DPT, unless 4th dose was given on or after 4th birthday, then only four (4) doses required.
 - **POLIO:** Four (4) doses of polio; 1 dose must be received on or after the 4th birthday. However, 3 doses meet the requirement if the 3rd dose was received on or after the 4th birthday.
 - **MEASLES:** Two (2) doses of measles vaccine are required for all students age 5 years and older who are born on or after September 2, 1991. First dose must be received on or after 1st birthday.
 - **MUMPS:** Two (2) doses of vaccine required for kindergarten entry effective August 1, 2009. First dose must be received on or after 1st birthday.
 - **RUBELLA:** Two (2) doses of vaccine required for kindergarten entry effective August 1, 2009. First dose must be received on or after 1st birthday.
 - **HAEMOPHILUS INFLUENZAE:** Type b vaccine will be required for children 18 months through 4 years of age.
 - **HEPATITIS A:** Effective August 1, 2009 two (2) doses of Hepatitis A required for kindergarten entry. First dose of Hepatitis A must be received on or after 1st birthday.
 - **INVASIVE PNEUMOCOCCAL:** Effective September 1, 2005, all children attending pre-kindergarten, Head Start, child-care facilities, or other early childhood programs must be vaccinated against invasive pneumococcal.
 - **HEPATITIS B:** Effective August 1, 1998, three (3) doses of hepatitis B vaccine are required for all students age 5 years and older who are born on or after September 2, 1992.
 - **VARICELLA VACCINE:** Two (2) doses of varicella vaccine are required for kindergarten entry effective August 1, 2009 or present documentation of previous varicella illness (chicken pox). First dose must be received on or after 1st birthday.
3. A copy of the child's social security card.
4. Proof of residency, which would include a copy of a utility bill that lists a physical address. A PO Box is not adequate proof of residency.
5. A copy of the birth certificate or drivers' license of the parent or guardian enrolling the student.

The school cannot accept any child as officially registered without the required documentation.
